PREFACE

Both of us served as law clerks to Edwin Cameron in the early 2010s. His impact on both our lives – professional and personal – has been enormous. It was not in question that we would produce a *Festschrift* for Edwin, if only we could. The question was when. An opportunity arose in 2021, when we had each, by vastly differing routes, found our way onto the staff of the University of Cape Town Law Faculty. We were still wet behind the ears, uncredible anonyms in the South African legal community, and almost entirely unprepared to lead a project of this kind. We had no right that it should succeed. Fortunately, however, the name of Edwin Cameron goes a long way. As soon as we sent out invitations to our intended authors, they came back with enthusiastic affirmations of their desire to participate and to honour Edwin.
